Impactful Achievements

We are excited to share that Little Flower Children and Family Services of NY and affiliate, St. John's Residence for Boys have received Council on Accreditation (COA) certification!


Accreditation means that both organizations deliver quality services that meet best national practice standards to clients, support employees, strengthen partnerships and relationships with legislative partners, donors, funders, and the community, and demonstrate compliance with oversight bodies.

This is a momentous milestone as it is the first quality recognition at the national level. It will have a long term positive impact on those we serve. This certification ensures Little Flower and St. John's are poised to join NY state in the implementation of the new Family First Prevention Services Act.

Little Flower and St. John's began the accreditation process more than a year ago while also navigating the COVID-19 pandemic. The process required the contribution and participation of countless team members and clients, numerous interviews with COA representatives, and site visits.

Accreditation is a badge of honor we will carry with us as we continue to strengthen our work of improving the well-being of the children, families, and people with developmental disabilities in our care.

Little Flower was recognized as a Sanctuary Resiliency Awardee by the ANDRUS Sanctuary Institute at their Sanctuary Network Conference.



Little Flower was recognized for upholding the Sanctuary model and our continued practice supporting our staff and clients throughout the pandemic. Sanctuary is an organizational change model that promotes safety and recovery from adversity by actively creating a trauma-informed community. Sanctuary recognizes that trauma is pervasive in the human experience, equally on both those seeking treatment and the people and systems who provide that treatment.

Some examples of what was done at Little Flower to help our community cope and manage throughout the pandemic include the sharing and promoting of an employee assistance program to address staff mental health needs, successfully launching and implementing telehealth services for families, distributing PPE and electronic devices to families in our community, regular virtual agency-wide check ins with the President & CEO, virtual grief resources and memorials for staff and clients, and the creation of an employee focused wellness program.


We are honored to be recognized for doing what is at the heart of our mission, improving and promoting the well-being of those in our community.


Message from the President & CEO - Corinne Hammons

I look forward to our continued partnership to achieve our goal of spreading holiday joy and magic to the children, families, and individuals with developmental disabilities in our care!


